1. In accordance with reference (a) the following Command Cronology covering the period 24 August to 30 September 1965 is submitted.

#### 3. Personnel.

- a. During the month of September this Battalion gained 81 enlisted and 1 officer.
- b. Our losses consisted of 1 officer (USMC), 7 enlisted (USMC) and the Battalion Doctor (USN).
- 4. Administration. The Battalion has experienced only minor administrative problems. A recommendation for Purple Heart was submitted 27Sep65 on SSgt L. M. RANCATTI (Co "B"), who had received a flesh wound from VC sniper fire.

#### 5. Civil Affairs/Military Government/Community Relations.

- a. The civil affairs and community relations are concentrated on the village of Hoa Khanh. Since the Battalion is centrally located to the hamlets comprising Hoa Khanh, our civic action program is directed entirely towards this village. Since arriving in this area the civil affairs officer has contacted the village chief, his council and hamlet leaders. Through the aid of ARVN interpreters, and their civil affairs teams, the village chief and civil affairs officer have established areas of security, responsibility, censorship and civilian control.
- b. Programs of assistance that this organization has accomplished in the local village are as follows:

ENCLOSURE (§)

- (1) An organized shopping center has been established with controlled prices, which are maintained under the jurisdiction of the village chief. Requests from tradesmen to establish shops in the shopping center are coordinated through the chief.
- (2) Censorship reports submitted to this Battalion by the village chief containing population count of adults and children, supplemented with current reports of refugees. The reliability of reports is the responsibility of the chief.
- (3) A recommendation has been submitted through channels to investigate increasing school facilities and requirements in the village.
- (4) Plans for the future include the possible hiring of local villagers to work in the camp and surrounding area. A list of recommended personnel having a clearance is being compiled by the chief for future reference.
- (5) Weekly meetings have been established with the chief in order that the Battalion legal officer may process villagers! claims for destruction of crops and property.
- (6) Medical aid for villagers has been established on a 3 day a week basis and approximately 50 adults and children are treated each day. During the reporting period a total of 477 civilians have been treated.
- (7) Dirt fill and grading has been furnished on a very limited basis. The new life hamlet of Phouc Long, however, was given 20 dump truck loads of fill to use as top soil. This consisted of spoil which was required to be removed.
- (8) Scrap wood chips have been distributed to each hamlet to be used for fuel.
- c. It is felt at this time that the civil affairs program and community relations can be considered excellent in all respects. One definite problem that hinders progress considerably, however, is lack of permanently assigned interpreters.

#### 6. Intelligence.

- a. Enemy action. The Battalion received two incidents of sniper fire, on 041720H Sep and 251055H Sep, in the vicinity of the Battalion area, one of which resulted in a casualty.
- b. As part of the security agreements made between the military and village leaders, information relating to VC activities will be referred

directly to this command. Nothing of importance was imparted to the Battalion during the reporting period.

11. Air Defense. At the present time this Battalion has 4, .50 Cal machine guns with anti-aircraft mounts, strategically located within the Battalion area. A defense overlay including these positions has been forwarded to the 3rd Marine Regiment.

### 12. Logistics.

a. Two ships, USS Vancouver and USS Thomaston, arrived off Da Nang,

during the early morning hours of 24 August 1965. Unloading operations commenced that same day utilizing landing craft over Museum Pier. Unloading was completed and all cargo and equipment had been moved to the Battalion camp by the evening of 26 August 1965. The USS Washburn arrived and unloading was commenced on 30 August 1965. Landing craft were again utilized only this time the Commercial Pier was used. Unloading was completed and all cargo was in the Battalion camp by the evening of 1 September 1965.

- b. Operations in conjunction with the establishment of a permanent camp for elements of this Battalion were commenced immediately upon arrival. To date 90 strongbacks for general purpose tents, seven strongbacks for command post tents, eight strongbacks for storage tents, four strongbacks for pyramidal tents, a 1600 man galley, nine "8 hole heads" and a temporary carpenter shop have been erected. Without messhall, film
- c. Battalion supply section has established a supply complex within the boundaries of the camp. Supplies currently on hand are as follows: Class I, 529 cases of MCI rations, Class II, as authorized by unit allowance list and as established by unit property record history data, Class III, 100 drums of diesel fuel and 75 drums of mogas, Class IV, as required, Class V, 8.5 S/T of small arms and .77 S/T of high explosives. Approximately 2900 requisitions have been processed of which 2100 have been sent to a higher echelon. Six hundred (600) empty 55 gallon drums have been salvaged of which 50 are used throughout the camp as trash barrels and 550 have been converted for use as culvert material.
- d. The Battalion aid station has treated 1467 military patients. There has been one battle casualty (leg wound from a ricochet), 26 men have been hospitalized and nine have been evacuated out of the area.
- e. The Battalion's motor transport equipment has amassed over 70,000 miles of operation and has hauled an estimated 65,000 yards of fill and sand, over one million board feet of lumber and timbers and 1500 S/T of other construction materials.
- f. The Water Supply Platoon has dug a well 120 feet deep for use within the Battalion camp. This well was not completed due to urgency of Headquarters Battalion cantonment requirements. The rotary well rig was at the Headquarters Battalion cantonment and drilling operations for a well there have begun. Four water points have been reestablished and have produced 1,776,716 gallons of potable water. Shower facilities have been provided for 18,784 men. A 70 foot drain line was installed at the III MAF messhall, 2,000 feet of two inch pipe were laid at Headquarters Battalion cantonment, 65% of external temporary plumbing was completed at Headquarters Battalion cantonment, and the laying of permanent external plumbing at the CG's quarters, ADC's quarters and

CG's mess were completed.

- g. The Battalion Maintenance Platoon has serviced/repaired 310 pieces of motor transport equipment and 118 pieces of engineer equipment. The welding shop has welded the 550 salvaged fuel drums into various lengths of culvert material. Telephone/electrical poles were fabricated out of bomb fin crates and 8 inch shell packaging. Eight inch shell packaging has also been made into underground drains and bomb fin crates have found usage as tent frame footings and supports for benches in the chapel. A contact team from the maintenance platoon has made two trips to Chu Iai to service this Battalion's equipment in that area.
- h. The Battalion mess section has been operating since the morning of 25 August and to date has served almost 70,000 individual meals.
- i. The Battalion's Construction Platoon during this period has received, stored, cut and delivered 260 strongbacks for general purpose tents. Twenty (20) strongbacks for general purpose tents have been constructed, nine "8 hole heads" were prefabricated, three sentry booths were built, timbers were cut as needed for various projects and lumber precut for the Battalion's 1600 man galley as required. Trained personnel were supplied to other units to train and supervise the construction of various buildings.
- j. The Battalion's Utilities Platoon has installed exterior wiring throughout the Battalion camp area, supplies a generator for the detachment at Chu Iai, supported the 3rd Engineer Battalion with 30 KW generator for 3 days, completed wiring 20% of the CG's house, and supplies the Battalion camp with electrical power on a 24 hour basis.
- 13. Major Construction Projects. During this reporting period the major projects completed and under construction are as follows:

### a. Completed.

- (1) Construction and operation of class 60 ferry in Da Nang.
- (2) Cleared and leveled air base perimeter.
- (3) Construction of a 150 foot class 60, M4T6 floating highway bridge across the Song Tuy Loan River in the vicinity of AT 946699.
- (4) Construction of a class 60, M6 standard bridge across the Song Can Bien River in vicinity of AT 072701. 195 AM

#### b. Under Construction.

(1) Construction of ammunition supply points # 1 and # 2 to contain Division and Wing class V supplies.

- (2) Construction of 500 man and 1600 man messhalls.
- (3) Construction of CG's and ADC's quarters.
- (4) Construction and maintenance of northern portion of Route 268.
- (5) Installation of water and sewage distribution systems for Headquarters cantonment.
- (6) Installation of primary and secondary power distribution system for Headquarters cantonment.
- (7) Construction of camp cantonment for the Second Battalions of the 3rd and 9th Regiments to include 291 strongbacks and five 500 man galleys (modified).


