4. <u>Administration</u>. Humerous personnel arriving as replacements without orders, service record books, pay records and health records. For receipt of these records definitely creates a personal hardship on the individual involved and delays proper personnel accounting procedures.

5. Civil Affairs/Tilitary Government/Community Relations

a. The civil affairs program continues on a daily basis. The following items were distributed between six harlets in the Hoa Fhanh Village.

- (2) The Dattalion sponsored, Vietnamese brich yard produced 6,000 soil-cement bricks.
- (3) Hr. James A. HARDHAY of Press Information Wollywood, California visited on C August 1966.

C. Logistics

- a. Correspondence originated by the Battalion S-4 of special interest was:
- (1) On 4 August a report of cantonment construction in this Battalion area was submitted to CG, 3d Marine Division.
- (2) On 5 August a letter was sent to Cormanding Officer FLSG "A" requesting open purchase of five, 55 GPM pumps for use at the Da Hang River floating bridge. The pumps were received on 14 August and put to irrediate use.
- (3) On S August this Battalion invoiced 286 pneumatic air mattreeses to 3rd Battalion, 9th Marines in accordance with OG, 3d MarDiv msg 250850Z Jul66.
- (4) On 6 August a 4 to 6 month stock level requirement was established for the pneumatic roller. These were in addition to those established for the same item on 15 January 1966.
- (5) On 8 August the Battalion issued field fortification material on a temporary loan to Detachment C-1, 5th Special Forces. The issue included 2500, 32 inch metal stakes; 5100, five foot metal stakes; and 8100, fifty foot reels of barbed wire.
- (6) On 9 August 1st Bridge Company received a special allowance of ten, 35 HP "Mercury" outboard engines to be evaluated for adaptation into the Marine Corps. They were evaluated and a report was sent to CG, 36 Harine Division on 2 September 1966.

- (7) On 10 August the Dattalion received a new family of radios consisting of the AM/PRC-25 and the AM/PRC-125. These were placed in service and are replacing the FRC-5 and PRC-10.
- (8) On 17 August three, 50 ton trestles were invoiced to MCD-9 for temporary use in supporting their bridge building program.
- (9) On 22 August an up to date report on requisition status of the Operational Status Follow-up was submitted to CG, Trapac.
- b. <u>Unbarkation</u>. During the reporting period the following were manifested for surface shipping:

c. Supply

- (1) 7th Engineer Battalion, FAF (NUC 21300). During the nonth of August, the supply platoon received and completed the Quarterly Obligation listing from C-1 and C-2. Puring the processing, approximately 1800 requisitions were reinstated, and 900 cancelled. For the month, there were 1/34 requisitions processed, 425 warehouse issues from stock and 1/12 material receipts from FLSG "A" and 3d FSR.
- (2) <u>lst Bridge Company, M.F. (RUC 21325)</u>. During the month of August, the Company Supply Section received and completed the Quarterly Obligation listing from C-1 and C-2. In processing, approximately 593 requisitions were reinstated and 211 cancelled. There were 292 requisitions processed, 42 filled from stock and 178 receipts from FLSG "A" and 3d FSR.
- d. <u>Messing</u>. The Battalion Mess Staff continued the normal mess operation of providing four meals daily except Sunday; the fourth meal being a midnight ration for the night crews. On Sunday, a brunch replaces breakfast and dinner.

o. Medical

- (1) The Battalion Aid Station was enlarged and the roof tinned. Approximately 646 military patients and 1270 Vietnamese Mationals were treated.
- (2) The Area Dental Facilities operations were intermittently interrupted due to mechanical equipment difficulties, but still, 306 patients were treated.
- f. Motor Transport. A total of 121,426 miles were logged on the Battalion's motor transport vehicles in support of operations.
- g. <u>Maintenance</u>. The Battalion Maintenance Platoon completed 94 pieces of engineer equipment and 121 pieces of motor transport equipment. A shortage of spare parts and maintenance personnel greatly curtailed maintenance activity for the period.

9. Training

- a. Troop indoctrination continues for newly arrived personnel and debriofing for those departing.
 - b. One marine of this Command attended Vietnamese Language School.
- c. Twenty-three personnel attended the 3d Engineer Battalion Land Mine Warfare School.
 - d. All other training was on the job training.
- 10. INC Warfare. Fone.
- 11. Command Control. Hone.
- 12. Air Defense. No change.

13. Special Operations

- a. On 26 August 1966, 6.2 miles of two lane, all weather road was opened from AT 947699 to AT 912577. This road will eventually be used to support the industrial complem of An Moa.
- b. Elements of 1st Bridge Company and Company "C", 7th Engineer Battalion supported two Roughrider convoys.
