- (5) Plague epidemic has been treated, with no new cases being reported in the last nine days.
- (6) Four separate schools are being built in Hoa Khanh village from the Chaplain's Fund.
- (7) A band concert was held at Hoa Khanh village for approximately 3000 villagers.

light, all Vietnamese Nationalists were told to come out of their homes, and from there were formed into a group and awaited further instructions. At this time, sweep teams entered the homes and held a thorough search of the homes. As the homes were searched, the people were questioned and checked for proper ID. A total of 12 people, 7 men and 5 women, were picked up and forwarded to ITT. Of the 12 people, 2 women were suspected as VC trained nurses, and 3 women taken for improper or no identification. One man had a large amount of money and medical supplies in his possession. Four men were deserters/or draft dodgers. Two men were picked up for no identification. All these people were forwarded to ITT, with the two nurses and one doctor marked for Counterintelligence and the others recommended to be forwarded to the District Chief.

8. Logistics

- a. Correspondence originated by the Battalion S-4, of special interest was:
- (1) On 7 June 1966 an urgent speedletter was sent to CG, FATPAC requesting expeditious supplying of repair parts for 315 air compressors and pneumatic drift drills. This request was generated by the continual requirement for this Battalion to maintain in operation two quarries.
 - (2) Administrative Plan 1-66 was published 161430H Jun66.
- (3) On 20 June 1966 authority to requisition replacements for four M-172 trailers without evacuation to higher echelon was requested from CMC.
- (4) On 22 June 1966 a report of repair parts required to upgrade equipment readiness was submitted to CG, III MAF.
- (5) On 25 June 1966 a listing of 2nd and 3rd echelon nondepot repairable items that this Battalion would like to hold in maintenance float was submitted to CG, 3d MarDiv.
- (6) On 30 June 1966 a letter requesting acquisition of land for new campsite of Company "A" was submitted to CG, 3rd MarDiv.
- b. Embarkation. During the period 17-30 June 1966, Company "B" was deployed via sea (YFU's) to the Phu Bai enclave. Embarkation Plan

c. Supply

- (1) During the month of June the Supply Section picked up the assets of Company "C", 7th Engineer Battalion which has been attached to 3d Engineer Battalion, 3d Marine Division for the past 8 years.
- (2) Made up all property record cards, locator cards and boxed the operating stock property for Company "B" for deployment.
- (3) During the month there were 4517 requisitions processed, 1116 warehouse issues from stock, and 3047 receipts from FLSG and 3d FSR.
- d. Messing. The Battalion Mess Staff continued the normal mess operation of providing 4 meals daily excepting Sundays, the fourth meal being a midnight ration for night crews. Sundays meals were scheduled as a brunch in the morning, normal evening chow and the midnight ration.

e. Medical

- (1) The Battalion Aid Station treated 1029 military patients while mobile teams treated 1045 civilians in conjunction with the Battalion Civil Affairs Activities.
- (2) The area dental facility commenced operation on 22 June, and treated 122 patients.
- f. Motor Transport. A total of 175,850 miles were logged on the Battalion's Motor Transport Equipment.
- g. <u>Maintenance</u>. The Battalion Maintenance Platoon completed repairs on 208 pieces of motor transport equipment and 177 pieces of engineer equipment.

9. Training

- a. Troop indoctrination continues for newly arrived personnel, and debriefing for those departing.
- b. One marine of this command attended Vietnamese Language School on Okinawa.
- c. Twenty-four personnel attended our own Battalion Motor Transport Operators' School. All twenty-four students were licensed.
 - d. All other training was on the job training.
